INVEST IN ANGOLA

Angola's high growth rate in recent years was driven by high international prices for its oil and thanks also to the strategy of diversifying its economy. Angola represents nowadays one of the most compelling investment opportunities on the continent.

Angola is one of the world's most promising frontier markets. It has an exceptional resource endowment and unparalleled investment opportunities.

The website of the National Agency for Private Investment (ANIP) and its various publications provide an overview of business opportunities and priority sectors of activities of the Angolan Government.

ostwar reconstruction boom and resettlement of asplaced persons has led to high growth rates in construction as well as in agriculture.

Since 2002, the Government has used billions of dollars in credit lines from China, Brazil, Portugal, Germany, Spain and the EU to rebuild Angola's public infrastructure.

The macroeconomic policy of the Government actively encourages foreign investors to invest in the creation of wealth in the country.

Private sector investment in infrastructural and other non-mineral projects is vital for the country to diversify its economy and tackle the development challenges that lie ahead.

Political stability and economic growth have reduced the risks of investment in Angola. The Government is committed to create incentives and to liberalize the markets.

Various incentives are already in place to attract interest from a broad spectrum of industry sectors. Further steps may be taken to stramline bureaucracy, simplifying the foreign investment process.

According to reports from the International Monetary Fund, Sub-Saharan African countries present very encouraging opportunities for growth and development. Now is the time to invest in Africa. The continent has not escaped from the global financial crisis but recent strong growth demonstrates the success of financial reforms and the emergence of a new and exciting financial era.

Political progress, democracy and progress towards the rule of law and respect for human rights, strong growth, stable inflation, financial security and rapid improvements in infrastructure distinguish Angola as one of the most dynamic economies on the continent.

The combination of all these factors encourages investors to invest in the country, to form partnerships with national companies and participate in the creation of national wealth, in a spirit of mutual interests which guarantees the return on investment and the repatriation and / or reinvestment of the profits.

Angola: President of the Republic highlights the country's progress over the last ten years

"National reconciliation implies, first of all, the perception that it is necessary to place the general interests, the interests of the nation, above any particular interest and thus guide ourselves by the essential values, like the values of the motherland, forgiveness, reconciliation, peace and defense of life, as a supreme good."

In an important and exclusive interview with the Portuguese television channel SIC, broadcasted on Thursday June 6, the President of the Republic answered several questions about Angola, Africa and international cooperation.

Giving an idea about Angola's general situation, the President of the Republic José Eduardo Dos Santos said that the last decade, in Angola, has been largely devoted to national reconciliation, the consolidation of the peace process, the revival of the political process and extensive programs of national reconstruction.

National reconciliation

About the national reconciliation the Head of State stressed: "national reconciliation implies, first of all, the perception that it is necessary to place the general interests, the interests of the nation, above any particular interest and thus guide ourselves by the essential values, like the values of the motherland, forgiveness, reconciliation, peace and defense of life, as a supreme good." President José Eduardo dos Santos said that in the early days, to cohabit with former enemies used to be difficult but necessary, "because, after all, the ultimate goal was to reconcile the Angolans, strengthen national unity and create the conditions for all Angolans, regardless of their origin, political and party affiliation, to participate in the great effort of national reconstruction, so as to build a nation that is everyone's pride."

Peace process

Touching on the peace process, the President of the Republic said: "after the war, in 2002, a peace and national reconciliation program was kicked off finally, in the course of which the formation of the Angolan Armed Forces could be completed by integrating the officers and soldiers of the UNITA military forces and by realizing the social integration of others actors of the society. More than four million displaced people had to be settled, conditions created to ensure food for them, thus ceasing the dependence from the World Food Program (WFP). He added that they have also started to intensively reunite families separated for many years, due to military instability and lack of security in many regions of the country".

Democratic process

About the revival of the political activity, the Head of State stressed the consolidation process of the democratic institutions and the creation of conditions for the deepening of democracy. Regarding the rule of law in Angola he added that several laws were passed to ensure political pluralism, the normal functioning of political parties and the creation of different associations, thus guaranteeing the right to free expression and the development of the private press.

Reconstruction

Touching on the reconstruction, the Head of State explained: "The country was destroyed and in blood. The provinces have almost become islands, because nearly all the roads and railways were destroyed". In the past decade, large-scale works have allowed reconstructing the network of roads and essential parts of the secondary railway network, the more than two thousand miles long iron transport system, as well as bridges, immense current generating and water treatment plants, and channels to transports these goods.

Education and training

The President explained that a comprehensive program of education and training of personnel was launched, schools, institutes rehabilitated and new schools built at all levels. The country has grown immensely in material and intellectual terms. "Now we are ready to face new challenges " he added.

He pointed out that he was proud of the efforts regarding human capital training and the creation of conditions to consolidate democracy, with general elections to be held periodically and the construction of facilities for the decent functioning of institutions, such as the grand Palace of the Parliament.

Combating corruption

Responding to a question on corruption, the Head of State said "I do not know if some day we will overcome the corruption. As you know, it is the world's oldest phenomenon and exists in every country, unfortunately even in the most developed ones. Clearly the Government's efforts should be focused to reduce this phenomenon as far as possible". President José Eduardo pointed out that the Government's policy aimed at combating corruption by improving regular salaries of public servants, strengthening the activity of the Audit Court, which oversees the State's accounts. He also stressed that in case of infringements, the offenders would always be held accountable, under the law.

International cooperation

About the international cooperation, answering the question of a journalist, the Angolan President José Eduardo dos Santos found the relations to be good with Portugal, Brazil, China and Israel, in the perspective of the development of Angola.

This was expressed by the Angolan vice president, Manuel Vicente, on behalf of the Head of State, José Eduardo dos Santos, while signing the declaration on the celebration of the foundation of the Organization of African Unity (OAU), currently the African Union (AU), on Saturday (May 25).

In terms of the 37-points declaration, the African leaders reiterated their commitment to continue the efforts aimed at eradicating racial discrimination and colonialism in all their forms.

The Heads of State also decided to revive the Pan-African congresses and incorporate them in the AU system.

They also renewed the commitment to see Africa free from conflicts and reiterated the determination to resolve, once and for all, the evil of conflicts and violence on the continent, and promote the consolidation of peace.

The African Heads of State expressed their decision to promote important changes in terms of democracy, good governance, science, technology and innovation.


The African statesmen pledged to promote the human development, the management of natural resources, environmental awareness and the competence related to the full regional development.

On the other hand, they appealed to the African citizens, including the Diaspora, particularly the women and youth, to actively participate in the process that will define the agenda of the African Union until 2063, with a view to a better Africa.

They also expressed confidence that in 2063 Africa will be free from poverty and conflicts, with sound environmental policies that have an influence on world matters.

The Declaration on the 50th anniversary of the foundation of the OAU/AU was signed during the 21st Summit of Heads of State and Government of the organization that started on Sunday and is closing on Monday in the Ethiopian capital, Addis Abbeba.

OPENING SPEECH OF THE FORUM BY H.E. THE AMBASSADOR OF ANGOLA IN HUNGARY

"I would specially like to thank Madam Maria Luisa Perdigão Abrantes, the President of the National Private Investment Agency in Angola, whose presence here today, her personal commitment and her recognized skills made possible the realization of this Forum in a short period of time".

The Ambassador stressed the role of the Hungarian Government in the realization of the Forum

"Our deepest thanks are extended to the Hungarian Government, particularly the Ministry for National Economy as well as the Ministry of Foreign Affairs. Both played a key role in realizing this Forum.

Therefore we are willing to extend this cooperation into economical, commercial, scientific, technical and cultural areas which hopefully will be consolidated and will be developed in the near future.

We remain convinced that Hungary, which is a country with a rich history, a diversified culture, a big opening to the world and which is a part of the European Union, has an eminently important role to play in Africa".

The Ambassador noted the progress made by Angola in the last 10 years and she invited Hungarian companies to invest in

"After a long period of devastating war which impacted the national economy, our country reconquered the peace since 2002 and the Angolan Government set up a vast policy of national reconstruction, policies for economic and social recovery as well as legal incentives and financial measures to help the investments.

These policies started to show positive results allowing our country to become the second most powerful regional economy behind South Africa and one of the major trade places for the exchanges between Africa and the rest of the world. Apart from the economic performances worldwide recognized, as it is by the IMF (International Monetary Fund), the World Bank, the European Community and some rating agencies, Angola became a stability factor in Africa. Indeed, the country not only regained the peace and political stability at national level, but it participates in peace processes in certain regions of the African continent.

Several countries of the European Union signed with our country, agreements to protect investments and put in place numerous financial operations to strengthen these agreements and facilitate the repatriation of profits. Nevertheless, the most important thing remains the attractiveness of the Angolan market.

So, it seems convenient to me to invite the Hungarian entrepreneurs to take the innumerable opportunities of investment in our country

During the last 10 years a considerable progress was realized. This progress concerns:

- The growth of the GDP(GROSS DOMESTIC PRODUCT) which was in average 10 % during the last ten years,
- The control of the inflation which allowed the stability of the currency and the prices,
- The diversification of the national economy which increased the activities of all the sectors not related to the oil and gas industry,
- The efficiency and the modernization of banks as well as financial institutions,
- The reconstruction and the construction of basic infrastructures,
- The setup of a flexible and attractive legal framework,
- The improvement of the accommodation conditions and the settlement of foreign companies and capitals.

In conclusion, I can assure you that the Angolan national economy is solid and allows the investors to perform in a politically stable and economically promising country".

She wished to stress that "Angola, with an attractive market of some 20,9 million consumers, is strategically located on the Atlantic coast of West Africa, where it acts as an open gateway to Southern and Central Africa by way of road and railroad networks".

She explained that "The ANIP is the Angolan Government entity responsible for the coordination of the national private investment policy, as well as its promotion and follow-up. This leads to the eventual approval and supervision of the execution of investment proposals presented to the Agency".

dame Maria Luisa Abrantes, President of the Board of Directors of ANIP had a particularly busy agenda for the Forum and bilateral meetings with the Hungarian authorities. During her visit in Budapest Dr. Maria Luisa Abrantes met with senior Government officials and Hungarian economic policy makers; she held an official meeting with Mr. Attila Holoda, Under-Secretary of State for Energy Affairs of the Ministry of National Development of Hungary.

John Wilson (Australia), spoke of the existence of various contacts between Angola and his country dating long years back, whose goal is to strengthen them.
